

19 Defendant Wyeth has filed a motion to dismiss without
20 prejudice the claims of the plaintiffs for lack of personal
21 jurisdiction. Alternatively, Wyeth also moves to dismiss the
22 claims of the plaintiffs for improper venue. The parties have
23 advised the court that counsel for all of the plaintiffs except
24 one (Loretta Harris) and Wyeth have reached an agreement with
25 respect to the present motion. The plaintiffs listed on Exhibit
26 A that reside in Alabama do not oppose the motion and the claims
of the plaintiffs listed on the exhibit that do not reside in
Alabama will be transferred to an appropriate venue following
remand to the transferor court. Therefore, the motion is moot
with respect to the non-Alabama plaintiffs. Loretta Harris did

1 not respond to the motion.

2 Based on the foregoing and based on the reasoning set forth
3 in Wyeth's memorandum in support of its motion to dismiss, the
4 court GRANTS Wyeth's motion with respect to Loretta Harris and
5 those plaintiffs listed on Exhibit A who reside in Alabama.
