THIS MATTER having come before the undersigned Judge on the Joint Motion for Stay of Defendants Chatter, Inc. ("Chatter"), The Delaco Company, as successor by merger to Thompson Medical Company, Inc. ("Delaco"), and Plaintiffs' Steering Committee; and the Court having reviewed this Joint Motion, and deeming itself fully advised,

IT IS HEREBY ORDERED that all cases pending in MDL 1407 and in all other federal PPA products liability cases in which Chattem or Delaco are named as parties, and only to the extent such cases relate to Chattem, Delaco, or distributors and retailers of Dexatrim[®] (but only to the extent such distributor's or retailer's alleged liability is premised on its sale of Dexatrim[®]) are hereby stayed, including all pretrial proceedings, and remand of pending cases to the transferor courts, with such stay being subject to the following provisions:

- a. The stay shall not affect Plaintiffs' obligations under and compliance with CMOs 6, 13, 13A, 15 and 15A;
- b. The stay shall not prevent the Parties from filing and opposing dispositive motions based on CMOs 6, 13, 13A, 15 and 15A;
- c. The stay shall not prevent the Court from ruling on any pending or future dispositive motions;
- d. The stay shall not prevent the Parties from seeking reconsideration of any ruling on a dispositive motion;
- e. Any Party who intends to file a dispositive motion not based on CMOs 6, 13, 13A, 15, 15A, shall, prior to filing such motion, comply with the following procedure. Such Party shall serve all Parties to this stay with a Notice of Intent to file such motion and shall attach a copy of the proposed motion. Within seven (7) business days from the date of such Notice, the Parties shall meet, confer and attempt to agree upon a briefing schedule and discovery issues (including the scope and procedures) for such discovery necessary to respond to such motion. If the Parties cannot agree on the

briefing schedule and discovery issues, the Parties shall schedule a hearing before the Court to address all issues concerning such motion;

- f. Chattem and/or Delaco may at its/their election attend and participate in a deposition of a Plaintiff in a case that is subject to this stay, if the deposition was noticed by a Defendant who is not subject to this stay, or by a Plaintiff against a Defendant who is not subject to this stay;
- g. The stay will not affect any stipulation or other written agreement entered into by the Parties concerning discovery to be entered into on or after the date of this Order.

IT IS HEREBY FURTHER ORDERED THAT the stay shall continue until further order of the Court, however, the parties may request modification of the stay by joint stipulation or by motion to the Court;

IT IS HEREBY FURTHER ORDERED THAT in the event this stay is lifted for any reason, the discovery deadlines as to the Defendant regarding which the stay is lifted shall be extended by the entire length of the stay.

IT IS HEREBY FURTHER ORDERED that to expeditiously identify those cases subject to the stay, for cases docketed in MDL 1407 after January 1, 2004, Plaintiffs shall comply with CMOs 13, 13A, 15 and 15A within fourteen days from the date the case is docketed in MDL 1407, and Plaintiffs shall comply with CMO 6 within thirty days from the date the case is docketed in MDL 1407;

believed to be affected by this Order is attached as Exhibit B. Defendants are ORDERED to serve a copy of this Order in all cases listed in Exhibits A and B.
