13 The Court, having reviewed the records of the cases listed  
14 on Attachment A, finds and rules as follows:

15 (1) Common discovery and other coordinated pretrial  
16 proceedings have been completed. All remaining issues are case-  
17 specific, and best determined by the transferor court.

18 (2) These cases will not benefit from further coordinated  
19 proceedings as part of MDL 1407, and are ready to be remanded to  
20 their respective transferor jurisdictions.<sup>1</sup>
