ORDER GRANTING MOTION TO
DISMISS WITH PREJUDICE FOR
FAILURE TO COMPLY WITH
COURT-ORDERED DISCOVERY
PURSUANT TO CMO 6 ON BEHALF
OF DEFENDANT WYETH

BEFORE the court is Defendant Wyeth's motion to dismiss Plaintiffs' claims with prejudice against all defendants for failure to comply with court-ordered discovery pursuant to CMO 6.¹ On March 18, 2002, the court entered Case Management Order ("CMO") 6 in which the court set a schedule and protocol for conducting all case-specific fact discovery within MDL 1407. Specifically, CMO 6 requires each plaintiff in every case to complete a Plaintiff Fact Sheet ("PFS") and serve it upon Defendants within forty-five days of receipt of the PFS. Defendant Wyeth now moves pursuant to Federal Rules of Civil Procedure 37 and 41 to dismiss the claims of the plaintiffs in the cases identified in Appendix A of this order against all defendants. The Court considered the briefs in opposition to Wyeth's motion,

1 and Wyeth's reply briefs in support of its motion.²

2
3 I. DISCUSSION

4 Before dismissing a case for non-compliance with court-
5 ordered discovery, the court must weigh five factors: (1) the
6 public's interest in expeditious resolution of litigation; (2)
7 the court's need to manage its docket; (3) the risk of prejudice
8 to the defendants; (4) the public policy favoring disposition of
9 cases on their merits; and (5) the availability of less drastic
10 sanctions. Malone v. United States Postal Serv., 833 F.2d 128,
11 130 (9th Cir. 1987). In the present case, plaintiffs have failed
12 to file fact sheets as required by CMO 6. Accordingly, the court
13 finds that dismissal is appropriate in light of the factors set
14 forth in Malone.

15 First, both the public's interest in the expeditious resolu-
16 tion of litigation and the court's need to manage its docket
17 dictate dismissal. Many of the cases subject to this order have

19 ²Wyeth filed two replies in connection with this motion. The
20 second was necessary due to the late service of one of the
21 plaintiffs' opposition papers. Accordingly, Wyeth's Motion for
22 Extension of Time in Which to Reply to Plaintiffs' Opposition is
23 GRANTED. In addition, Plaintiffs moved to file a surreply to
24 address various issues they believe first were raised by
25 Defendant in its initial reply brief. Specifically, plaintiffs
26 seek to respond to Defendant's arguments regarding fact sheets
that were not served until after Defendant's motion to dismiss
was filed. However, it was Plaintiffs who served approximately
114 fact sheets in the weeks following the filing of Wyeth's
motion. Therefore, Plaintiffs put Defendant in the position of
having to address the late fact sheets on reply. Accordingly,
leave to file the surreply is DENIED.

1 been on file for over a year. During that time, plaintiffs have
2 not moved their cases forward. Such lack of diligence does not
3 serve the public interest in expeditious resolution of litiga-
4 tion. See Yourish v. California Amplifier, 191 F.3d 983, 990
5 (9th Cir. 1999) ("dismissal in this instance serves the public
6 interest in expeditious resolution of litigation as well as the
7 court's need to manage the docket because Plaintiff's noncompli-
8 ance has caused the action to come to a complete halt, thereby
9 allowing Plaintiff to control the pace of the docket rather than
10 the Court").

11 Second, the unreasonable delay in completing the fact sheets
12 prejudices the Defendants' ability to proceed with the cases
13 effectively. The PFS is designed to give each defendant the
14 specific information necessary to defend the case against it.
15 Without that discovery device, a defendant is unable to mount its
16 defense because it has no information about the plaintiff or the
17 plaintiff's injuries outside the allegations of the complaint.
18 Plaintiffs served 114 fact sheets between the filing of Wyeth's
19 motion to dismiss on August 13, 2003, and the date of Wyeth's
20 initial reply brief, September 30, 2003. See Wyeth's 9-30-03
21 Reply in Support of its Motion to Dismiss at 4. In addition, many
22 plaintiffs who served facts sheets late served incomplete fact
23 sheets. See Wyeth's October 22, 2003 Reply in Support of its
24 Motion to Dismiss at 3-5. Presumably, Plaintiffs served the late
25 fact sheets in a last-ditch effort to comply with CMO 6. How-
26 ever, the unreasonable delay in producing this information

1 severely prejudices the Defendants, warranting dismissal.³

2 Pagtalunan v. Galaza, 291 F.3d 639, 642-43 (9th Cir. 2002).

3 Third, where there is a preference that cases should be
4 disposed of on the merits, here, given the inability of the named
5 plaintiffs to provide information regarding the critical elements
6 of their claims, it is impossible to dispose of these cases on
7 the merits. Plaintiffs are uniquely in the possession of the
8 information being sought. Their inability or unwillingness to
9 furnish this information, or their serious delay in doing so, is
10 not excusable. See In re Exxon Valdez, 102 F.3d 429, 433 (9th
11 Cir 1996) ("policy [of disposing cases on their merits] lends
12 little support to appellants, whose total refusal to provide
13 discovery obstructed resolution of their claims on the merits.").


14 There are no less drastic sanctions remaining. All the
15 named plaintiffs have received warning letters from the Defen-
16 dant. These letters prompted no response. The court has already
17 imposed the sanction of preventing remand of the cases where
18 discovery requirements have not been met. See CMO 10 ¶ 2 (Nov.
19 21, 2002). The court also ordered that the time for completing
20 case-specific discovery will not begin to run until a substan-
21 tially complete PFS has been provided to defendants. Id. ¶ 3.
22 And now, even at the doorstep of dismissal, many of the named

24 ³On October 22, 2003, Defendant filed a revised list of
25 cases with delinquent fact sheets, reflecting its decision to
26 withdraw its motion as to certain plaintiffs. Therefore, this

1 plaintiffs still fail to comply. In the situation where the
2 court has been lenient and provided plaintiffs with second and
3 third chances following procedural defaults, "further default[]
4 may justify imposition of the ultimate sanction of dismissal with
5 prejudice." Malone, 833 F.2d at 132 n.1 (quoting Callip v.
6 Harris County Child Welfare Dep't, 757 F.2d 1513, 1521 (5th Cir.
7 1985)).

8 Accordingly, the court finds it appropriate to dismiss the
9 named plaintiffs' claims against all defendants with prejudice.
10 For the foregoing reasons, Defendant's motion to dismiss for
11 failure to comply with court-ordered discovery pursuant to CMO 6
12 is GRANTED. The claims by the plaintiffs listed in Appendix A
13 against all defendants are DISMISSED with prejudice.
