8 The order dated at Seattle October 17, 1944,
9 for the division and assignment of this Court's business
10 among the Judges is hereby amended only in the following
11 particulars:

12 Judge Black will hereafter dispose of all indict-
13 ments and informations charging illegal entry of aliens
14 hereafter filed or pending at Seattle and all applications
15 and hearings in connection therewith.

16 All matters relating to grand juries and their
17 sessions will be handled at Seattle by Judge Bowen, and at
18 Tacoma by Judge Leavy.

19 All assignments to the calendars of the respective
20 Judges, needed to accomplish the foregoing, will be promptly
21 made by the Clerk.

22 Said order of October 17, 1944, is hereby amended
23 in accordance with the foregoing.
