8 In accordance with the authority conferred by 28 U.S.C. § 631, et  
9 seq., and further authority granted and action taken by the Judicial  
10 Conference of the United States, it is

11 ORDERED that Ira J. Uhrig is hereby appointed part-time United  
12 States Magistrate Judge, with official station at Bellingham,  
13 Washington, at the salary fixed by the Judicial Conference of the  
14 United States for the designated official station.

15 The said United States Magistrate Judge shall enter upon the  
16 performance of his duties at Bellingham, Washington, on the 21st day  
17 of July, 1993, or as soon thereafter as he may be sworn in.  
18 If possible, he shall take the oath or affirmations prescribed by 28  
19 U.S.C. §§453 and 631 and 5 U.S.C. §3331 before the 21st day of  
20 July, 1993.

21 The said part-time United States Magistrate Judge is to hold and  
22 discharge the duties of said office for a term of four (4) years from  
23 the 21st day of July, 1993, unless sooner removed,  
24 subject to the provision of 28 U.S.C. §631(c).

25 The said United States Magistrate Judge is hereby specifically  
26 designated to exercise jurisdiction to try persons accused of, and  
sentence persons convicted of, misdemeanor offenses committed within

1 the Western District of Washington, as those terms are used in  
2 18 U.S.C. §3401(a).

3 The Clerk shall cause certified copies of this order to be  
4 delivered to the said United States Magistrate Judge and to the United  
5 States Attorney for this district; shall cause certified copies of  
6 this order to be spread upon the records of the court at Seattle and  
7 at Tacoma; and shall forward a certified copy of this order to the  
8 Director of the Administrative Office of the United States Courts as  
9 required by 28 U.S.C. §631(h).
