10 DIVISION OF COURT BUSINESS GENERAL ORDER

12 Pursuant to the provisions of Title 28, United States Code,
13 Section 137, it is hereby agreed and ordered by the active judges
14 of this court that the division of this court's business among
15 said judges shall be as hereinafter stated:

- 16 1. As used herein:
17 A. Civil cases include bankruptcy appeals, habeas corpus
18 petitions, and contested miscellaneous matters, but
19 excludes Section 2255 motions and other similar cases
20 described in paragraph 8.
21 B. Criminal cases include appeals from Magistrate Judges
22 and all proceedings under Rules 7, 20 and 40 FRCrP.

- 23 2. All civil cases filed in this district shall be assigned
24 as follows:
25 -- All civil cases at Tacoma equally to the active
26 district judges.
-- All civil cases at Seattle equally to the active
district judges.

3 3. All criminal cases filed in this district shall be
4 assigned as follows:

5 -- All criminal cases at Tacoma equally to the active
6 district judges.

7 -- All criminal cases at Seattle equally to the active
8 district judges.

9 4. All naturalization proceedings at Tacoma, including
10 contested petitions, shall be handled by Judge Robert J. Bryan.

11 5. Judge Robert S. Lasnik shall be responsible for the call
12 and discharge of grand juries, the return of indictments, and all
13 other matters related to the functions of the grand juries.

14 6. Judge Thomas S. Zilly shall be responsible for all
15 issues involving the jury selection process and the call and
16 qualification of petit jurors. Judge Robert J. Bryan shall be
17 responsible for the call and qualification of petit jurors and
18 the jury selection process in Tacoma.

19 7. Judge William L. Dwyer shall be responsible for all
20 naturalization proceedings at Seattle, including contested
21 petitions.

22 8. Judge Barbara Jacobs Rothstein shall be responsible for
23 all claims for wages and effects of deceased and deserting
24 seamen; and unassigned ex parte matters in Seattle. Judge
25 Franklin D. Burgess shall be responsible for all claims for wages
26 and effects of deceased and deserting seamen; and unassigned ex
parte matters in Tacoma

3 9. Proceedings under Section 2255, Title 28, United States
4 Code, shall be assigned to and handled by the Judge who imposed
5 the sentence involved.

6 10. If immediate action is necessary in any case or
7 proceeding assigned to a particular Judge and that Judge is
8 unavailable for any reason, any other Judge may hear and dispose
9 of the matter requiring immediate attention, but such action
10 shall not constitute reassignment of the case or proceeding.

11 11. A. When civil or criminal actions involving a common
12 question of law and fact (but not necessarily the same parties)
13 are assigned to different Judges and it appears to any Judge of
14 this court that there may be good reason to assign all of said
15 actions to one Judge, such may be assigned to the Judge to whom
16 the case bearing the earliest filing date was assigned, at his or
17 her option.

18 B. Motions to consolidate civil or criminal actions
19 for trial, or otherwise, shall be heard by the Judge to whom the
20 case bearing the earliest filing date has been assigned, and in
21 the event consolidation is ordered, the consolidated cases shall
22 be heard by said Judge.

23 12. The reassignment of a case necessitated by the
24 disqualification of a Judge shall be to the Judge to whom the
25 next case filed would have been assigned; the Judge who has
26 disqualified himself/herself shall be assigned an additional case
the next time his/her name is reached in the assignment wheel.

3 13. The assignment of all civil and criminal cases as above
4 noted is made subject to such change or changes as may be
5 established by the Chief Judge for the purposes of equalization
6 of case assignments to all active Judges of the district.

7 14. The Clerk shall refer any matter or proceeding not
8 provided for under this division of business order to the Chief
9 Judge for assignment or disposition.

10 15. Notwithstanding the foregoing provisions, each of the
11 Judges of this court shall have and perform any and all acts of
12 authority and duty otherwise by law conferred upon him or her to
13 hear, try and dispose of any and all of the cases, matters and
14 business of this court when he or she consents to do so.

15 16. All conflicting orders concerning the division of this
16 court's business heretofore entered are vacated by this order.
17 This order shall be effective immediately and remain in force
18 until rescinded.
