The Court has reviewed the parties’ joint motion seeking termination of the Sustainment Plan provisions of the Consent Decree. The Court GRANTS the motion and orders as follows:

- (1) The Court terminates paragraphs 69-168 of the Consent Decree and all related monitoring upon finding that the City has sustained full and effective compliance with those paragraphs for two years, pursuant to paragraphs 223 and 229, and
- (2) The City shall file a response to the issues raised in the Court’s May 21, 2019 Order (Dkt. 562) no later than August 1, 2020.
