IT IS ORDERED that the Local Rules for the Western District of Washington are amended by adoption of the following addition to Criminal Rule 62, Conduct of Proceedings in a Widely Publicized or Sensational Case:

Such special order may be addressed to some or all of the following subjects:

- (1) A proscription of extrajudicial statements by participants in the trial, including lawyers, parties, witnesses, jurors, and court officials, which might divulge prejudicial matter not of public record in the case;
- (2) Specific directives regarding the clearing of entrances to and hallways in the courthouse and respecting the management of the jury and witnesses during the course of the trial so as to avoid their mingling with or being in the proximity of reporters, photographers, parties, lawyers, and others, both in entering and leaving the courtroom and courthouse, and during recesses in the trial;
- (3) Specific direction that the jurors refrain from reading, listening to, or watching news reports concerning the case, and that they similarly refrain from discussing the case with anyone during the trial and from communicating with others in any manner during their deliberations;

- Insulation of witnesses from news interviews

  - (a) An order that no member of the public or news media representatives be at any time
  - (b) The allocation of seats to news media representatives in cases where there are an excess of requests, taking into account any pooling arrangement that may have been agreed to among

The above 11st of subjects is not intended to be exhaustive, but is merely illustrative of subject matters which might appropriately be dealt with in such an order.

This amendment shall be effective February 20, 1970.
