The opening paragraphs of the schedule are amended to read as follows:

Where the word "mandatory" appears in the bail column, or the offense is not listed in this schedule, the defendant must appear in court. Disposition by payment of a fixed sum in lieu of appearance is not authorized. It is the intent of the court that some petty offenses are serious enough that, even though the defendant does not wish to contest the case, and the Magistrate intends to impose only a fine, the defendant should be required to appear in a court.

In some cases, although mandatory appearance cases according to this schedule, the Magistrate will be aware that in the particular circumstances no court appearance need be required. In such cases the Magistrate may, after asking the views of the charging agency, authorize disposition of the case upon payment of a sum which he shall fix for the particular defendant.

When an amount is specified in the bail column, termination of the proceeding upon payment of this sum in lieu of appearance is authorized unless the Magistrate shall set a different sum, or require an appearance, for a particular defendant.
