RE: 9213 Numbering System, Phase I

Subject to formal approval by Judge Craig which we anticipate shortly, an experimental plan for assigning "sub-numbers" to each distinct dispute within the case has been proposed. The objective is to assist all offices in handling the substantial flow of paperwork. We can have more confidence that we have all pleadings relating to a given dispute. Sub-files can be closed as matters are completed.

These procedures are suggested:

- (1) We will require the parties to use a sub-number on all papers filed, except routine administrative documents. The Clerk's Office will return any documents which do not comply.
- (2) George Dysart has agreed to be the "sub-number consultant." Before a party files a "Request For Determination" or other document that initiates a new proceeding, counsel will call George Dysart and secure his recommendation as to which matters warrant assignment of a separate sub-number. Magistrate Weinberg will substitute when necessary.
- (3) Counsel will then call the Clerk's Office who will assign the next available number (e.g. 9213/85-107).
- (4) The initial paper must bear the sub-number when filed and served. All subsequent papers related to the same dispute must bear the same number.
- (5) In implementing this system, we will identify and assign sub-numbers to all presently active matters. Future papers will bear these numbers.
- (6) The Clerk will continue to file and docket all papers in 9213; the docket numbers will reflect the sub-numbers.

George Dysart has submitted a list of pending cases deserving sub-numbers. Please see enclosure. We request that you add to or delete from this list and return by May 10, 1985. We are hoping to effect the new system as soon as possible so your cooperation will be appreciated.
