## 2016 Ninth Circuit Civics Contest

The theme of the contest is the United States Supreme Court's landmark 1966 decision in Miranda v. Arizona. The court ruled that someone taken into police custody must be informed – prior to questioning – of their Fifth Amendment right against self-incrimination. The decision became the basis for what is now referred to as a "Miranda Warning" or a recitation of "Miranda Rights."

The contest has two components: 1) Individual students can express their thoughts and ideas in an essay of 500 to 750 words, and 2) Individual students or teams of up to three students may submit a 2-3 minute video presentation on the theme. Students may participate in one or both competitions.



The contest is open to sophomores, juniors and seniors attending public, private, parochial and charter schools and home-schooled students of equivalent status. Students must be residents of Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, Oregon, Washington, the U.S. Territory of Guam and the Commonwealth of the Northern Mariana Islands.

## Filing Reminders:

• Signatures on documents electronically filed can be either a digital signature or the "s/ Name" typed on the signature line and has the same force and effect as an affixed signature on a paper copy of the document.

#### See: LCR 11 SIGNING FILINGS; SANCTIONS

a) Signature

A document signed electronically (by either a digital signature or by using the "s/ Name" convention) has the same force and effect as if the person had affixed a signature to a paper copy of the document. Electronic signatures must be in conformance with this district's Electronic Filing Procedures for Civil and Criminal Cases.

• When filing the Joint Status Report do not include requests for relief from the court:

(a) Scheduling Conference or Joint Status Report

(1) Joint Status Report. In their joint status report, the parties must address all of the topics set forth in Fed. R. Civ. P. 26(f)(3) and in LCR 26(f).

Parties should not include requests for relief from the court in the joint status report, and the court typically will not rule on such requests. Rather, requests for relief should be contained in a stipulated motion, where feasible, or in a motion.

# Magistrate Judge-Select Paula McCandlis

The United States District Court for the Western District of Washington is pleased to announce that Paula L. McCandlis has been selected as our next part-time magistrate judge in Bellingham. She will replace Judge Dean Brett, who will retire on May 1, 2016.

Magistrate Judge Select McCandlis has practiced law in Bellingham since 1997, and is currently a co-managing partner/shareholder with Brett, McCandlis Brown, PLLC. She practices civil litigation, personal injury law, and before that practiced family law and criminal law. Ms. McCandlis has a long record of mediation and collaborative law.

In addition to her practice, Ms. McCandlis volunteers for LAW Advocates, offering free legal services to low-income members of the community. She is also a Commissioner Pro Tempore for Whatcom County Superior Court as well as Bellingham Municipal Court.

Ms. McCandlis grew up in Washington State, and is a graduate of the University of California Santa Cruz. She attended Gonzaga University School of Law.

Ms. McCandlis has begun the background investigation process, and is expected to transition into the role in May, when Judge Brett retires after more than 10 years of dedicated service to the Western District of Washington.
