Ninth Circuit Civics Contest

Submissions are now open for the 2017 Ninth Circuit Civics Contest, Not to Be Forgotten: Legal Lessons of the Japanese Internment!

The 2017 Ninth Circuit Civics Contest is an essay and video competition open to young people in Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, Oregon and Washington, along with the U.S. Territory of Guam and the Commonwealth of the Northern Mariana Islands. Students in grades 9-12 in public, private and parochial schools or home-schooled students of equivalent grade status may enter. Individual students can compete in the essay contest, while individuals and teams of up to three students can enter the video contest.

Prizes of \$2,000, \$1,000 and \$500 will be awarded to the first-, second- and third-place winners in both the writing and video competitions. The deadline for submissions is April 17, 2017. Winners will be announced in June.

Search Feature

The search option on the tool bar allows users to locate a menu or event item.



Type in short document title/word. Search feature will display all events with the word. Select the appropriate event and proceed with filing of your document.

Filing a Civil Summons

We strongly suggest you use the fill-able summons form found on the Court's website. Download and save the summons form before filing in your case. If you choose to use your own summons, it must comply with LCR 4 and Fed. R. Civ. P. 4 Summons.

REMEMBER

- \square Each summons must be filed as a separate attachment
- \square Summons(es) will be issued electronically by the court the following day
- ☑ You will receive a Notice of Electronic Filing (NEF) of the issued summons when the Clerk's Office enters it on the docket

Use the NEF hyperlink to retrieve the issued summons to effect service of process

Locate and add each summons in the same manner as all other attachments. Select Summons from the Category dropdown menu. If desired, you may also add a description in the text box.



Judicial Institute for High School Teachers

The Court, in collaboration with Seattle University, has developed a 3 day workshop for high school teachers. The program includes presentations by federal judges, attorneys, and law enforcement officers on topics such as First Amendment rights, civil rights, search and seizure law, and the role of the grand jury. Teachers will also observe actual court proceedings, followed by a question and answer session with the presiding judge.



This 3 day program is offered to high school teachers who teach in western Washington, within the Court's geographic boundaries. There is no cost for the program, and clock hours are offered. Overnight accommodations are also included.
